TIER 1 TESTING SERVICES and FEES

DUA COLLECTION and ALCOHOL TEST FEES

- \$20.00 Urine Drug Collection Only Fee (DOT or NON-DOT)
- \$25.00 Breath Alcohol Test (DOT or NON-DOT) Includes automatic EBTConfirmation
- \$30.00 Urine Drug Rapid Collection with Rapid Screen (if Provided)

AFTER HOURS / ON-SITE FEES

- \$60.00 After Hours or Trip Fee SCHEDULED* (24 hrs in advance)
- \$80.00 After Hours or Trip Fee URGENT* (24/7 On-Call Service)
- \$40.00 Additional Hour(s) "wait time" or out of area travel time or Additional Collector if required.

 *After Hours or Trip Fees include up to one hour. Additional Hours fee waived with 4 or more collections or tests per hour. Normal Office hours at Tier 1 Testing site are Monday through Friday, 8 am to 5 pm. Extended Hours (7am-7pm) will be provided at no additional charge when arranged 4 hours in advance and no additional trip is required by site staff.

DRUG TEST FEES

- \$50.00 Urine Drug Test 5 Panel NON-DOT Bundle*
 - All "Bundles" include forensic collection, adulterant check, screen, confirmation and report
- \$58.00 Urine Drug Test 5 Panel Bundle (DOT or NON-DOT with Medical Review)*
- \$65.00 Urine Drug Test 10 Panel Bundle (MedTox MedPro-1 or equivalent)
- \$65.00 Urine Drug Test EtG Only
- \$85.00 Urine Drug Test 10 Panel with EtG Bundle
- \$95.00 Urine Drug Test 12 Panel with EtG Bundle
- \$50.00 Medical Review of Positives (NON-DOT of positives as requested)

RANDOM MONITORING Programs

In addition to the testing fees above that apply, participant's in Tier 1 Testing's Random Monitoring Program may be subject to the following charges

- \$50.00 Monitoring Application & Set up Fee
- \$15.00* Monthly Monitoring Fee (for administrative cost of managing, notification etc)
- \$25.00 Failed to Complete Fee (for any missed random not exempted at least 24 hrs in advance)
 - *Monthly Monitoring Fees will be WAIVED for clients who meet ALL the following criteria

Set up on 13+ per year program with reporting to single oversight

Set up on AutoCharge Payment (Visa or Master Card) at time of collection
